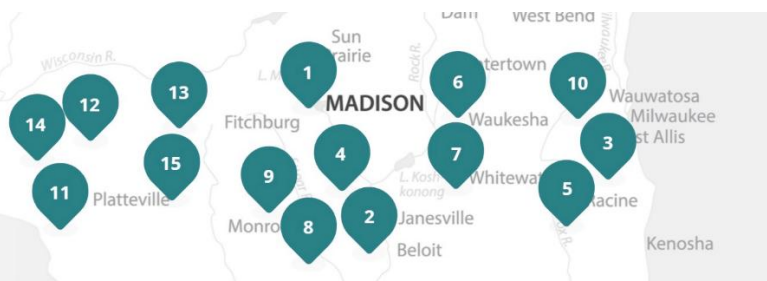

As we continue our partnership with Farmers Savings Bank, we wanted to share an important update about our upcoming core system conversion.

To ensure we provide the best possible experience for our customers and employees, we have made the decision to move our core conversion date to **May 24, 2027**. As a community bank, we work closely with our trusted vendors and partners. This additional time allows us to make the transition as smooth and seamless as possible.

Here is what you can expect:

- * Continue banking as you always have. Your checks, debit cards, online banking, and existing services are expected to continue working as usual through the updated conversion date listed above. If you ever experience a transition-related concern with your account, please contact us so we can make it right.
- * Your existing Farmers Savings Bank routing number will continue to work through the conversion date listed above. No action from you is needed at this time.
- * Reissued or expired debit cards will be updated with the Bank CMG branding. Those cards will arrive by mail with instructions. We will never call, text, or email you asking you to “activate” a card or to provide your card number or PIN.
- * Your account activity, including direct deposits, automatic payments, and recurring withdrawals, will continue to process as it does today. If action is required on your part, we will communicate with you well in advance.
- * We will be here to answer your questions and provide support before, during, and after the conversion to ensure a smooth transition.
- * As of **August 3, 2026**, you now have access to banking services at all 15 Bank CMG locations, giving you even greater flexibility wherever life takes you.

* Website and online banking: Starting **September 14th 2026**, the Farmers Savings Bank website will redirect you to BankCMG.com. To log into your existing accounts, click "Sign In" > Online Banking and follow the prompts to log in. For your security, always type BankCMG.com directly into your browser and bookmark into your favorites. We will never email or text you a link to login and "verify" your account.

* Email addresses: Around **mid-September 2026**, Farmers Savings Bank email addresses will transition to BankCMG.com. You can continue using existing Farmers Savings Bank email contacts, and your message will still reach the appropriate team member. However, their reply will come from a Bank CMG email address, so you may wish to update your address book over time. If an email claims to be from the bank and asks for personal or account information, please call us before responding.

*Your deposits remain FDIC insured. If you hold deposits at both Farmers Savings Bank and Bank CMG, FDIC rules provide that your deposits remain separately insured for at least six months after the merger and CDs until they mature.
